It was highlighted that both General Manager and Marine Manager are back to home schooling with lockdown restrictions and they may need flexibility of work hours to allow for that.

• Marine and Taigh Solais Report – Rob Macdonald

Marine

Harbour is currently only open to commercial vessels, and as a port of refuge. This will continue until government legislation changes.

Covid-19 and the future. As it stands, we are still working towards a season.

Our Challenge as the marine team is to try and prepare for one of our busiest seasons, whilst at the same time preparing for no season... many challenges – such as staffing, rotas etc.

We need to prepare to be busy. If lockdown and the evertightening restrictions and the vaccines do their job things will begin to open up again by the end of March.

Our aim as last year is to keep both visitors and locals safe, balancing that with the needs and wants of the community. Our first (small) cruise ship is due on the 9th of May. As things stand, we need to be prepared to accept these vessels. The cruise industry needs our support. We are expecting (if the vessels are allowed to run, and they do in fact run), that they will have very limited numbers, and strict regimes on board. It is sounding like most passengers will be tested when they go aboard the vessel.

Again, as last year, rules and guidance will be changing continuously – so we will be monitoring that. Trying to keep 2 separate teams where possible, so that we don't all end up self-isolating at the same time.

There are going to be many challenges, I don't think things will return to normal this year but I think we should look forward to this season as being one of our best.

The Marine Team are working through the list of items we need to complete before the start of the season. We will be meeting next week to make important decisions on this year.
